

RE-ROOFING MITIGATION 1 & 2 Family

To be filled out and included with all 1 & 2 Family Residential Re-Roofing applications.

Florida Building Code, Sixth Edition (2017), Existing Building.

Section 706.7.2 - Secondary Water Barrier:

A secondary water barrier shall be installed using one of the following methods when roof covering is removed and replaced:

FOR: Asphalt shingles, Metal roof shingles, Mineral-surfaced roll roofing, Slate and slate type shingles, Wood shingles, Wood shakes, Metal roof panels, Photovoltaic Shingles:

Shall comply with Section R905.1.1 of the Florida Building Code, Residential, 6th Edition 2017.

FOR: Clay or Concrete Tile

Shall comply with the manufacturer instructions or the FRSA/TRI Florida High Wind Concrete and Clay Roof Tile Installation Manual, 5th Edition.

Section 706.5 - Reinstallation of materials:

Existing slate, clay or cement tile shall be permitted for reinstallation, except that damaged, cracked or broken slate or tile shall not be reinstalled.

Roof Diaphragm

Contractor acknowledges that as required by Florida Building Code Sixth Edition (2017), Existing Building Sections 706.7.1, 706.7.2, 706.8, the structure will be evaluated and noted within Re-roof affidavit.

FBC-EB 6th 2017 706.8 & Collier County Ord. 93-62: Roof to wall connections:

When a roof covering on an existing site-built single-family residential structure is removed and replaced on a building, permitted before September 14, 1993, that has an appraised value of \$300,000 or more, roof to wall connections shall be improved as required by Section 706.8.1.


