Rev.2 08/16/2022 UPDATE: CORNER OFFSET DISTANCE TO DRIVEWAY ACCESS (DEVIATION REQUEST) – Deviation request memo does not provide justification to why the ROW Construction Standards cannot be met (based on existing ROW or site constraints); yet the memo provides reasoning why the County should grant it.

-Deviation Request will not be considered at this time, as the site seems to have enough frontage (290') to meet code.

If 27th CT SW is an arterial or collector roadway indicate this on your plans and a wall would not be required per LDC Section 5.03.02.H.1.d.

Correction Comment 8:

Provided site plan shows "shaded seating area" along Santa Barbara. Provide information as to the size and type of shade structure used.

Movable awnings shall not project over three (3) feet into a required yard, provided that where the yard is less than five (5) feet in width the projection shall not exceed one-half (1/2) the width of the yard.

If using an awning provide the above encroachment information.

- Please be advised that Sections 10.02.03.H.1, and 10.02.04.B.3.c require that a resubmittal must be made within 270 days of this letter.

 All required FDEP Permits must be submitted prior to scheduling the pre-construction meeting.

Stipulations:

• At the pre-construction meeting, the site development contractor shall be reminded to notify Engineering Inspection Services (Joe.Bianchi@colliercountyfl.gov) for an inspection of the exfiltration trench and stormwater chambers prior to final backfill to assure proper gradation of stone and installation of filter fabric.

Stipulations:

• A copy of the FDEP 10/2 Self-Certification is required at the pre-construction meeting.
